Ratifications for Belize

- 50 Conventions and 1 Protocol
- Conventions:
 - 8 Fundamental Conventions
 - 2 Governance (Priority) Conventions
 - 40 Technical Conventions
 - 35 are in force
 - 11 denounced
 - 2 abrogated

Articles 19 & 22

- Article 19 of the ILO Constitution:
 - Report on the position of the national laws and practice regarding matters dealt with in unratified Conventions and Recommendations.
- Article 22 of the ILO Constitution:
 - Report on the measures taken to give effect to the provisions of ratified Conventions.

<u>Reports are drawn up in accordance with the approved Report Form</u>

2022 Reporting Cycle

- Art. 22 Submission 1st June, 2022 to 1st September, 2022
- Art. 19 Submission 28th February, 2022
- Six (6) Article 22 Reports due for **2022**:
 - 1) Labour Inspection Convention, 1947 (No. 81)
 - 2) Radiation Protection Convention, 1960 (No. 115)
 - 3) Paid Education Leave Convention, 1974 (No. 140)
 - 4) Tripartite Consultation (International Labour Standards) Convention, 1976 (No. 144)
 - 5) Labour Relations (Public Service) Convention, 1978 (No. 151)
 - 6) Occupational Safety and Health Convention, 1981 (No. 155)

Timeline

Reporting on International Labour Standards begins at the start of every calendar year:

- a) FEBRUARY: Communication of reports due;
- b) MARCH-APRIL: Submit requests to stakeholders;
- c) MAY: Draft reports;
- d) JUNE: Consult with representatives of employers and workers' organizations via the Labour Advisory Board
- e) JULY: Prepare final reports;
- f) AUGUST: Complete formal approval process (submit to Cabinet);
- g) SEPTEMBER: Submit final reports to ILO.

Consultation

Consultation cont.

<u>Prior 2017</u>

- I. The Ministry submitted Articles 19 and 22 reports to representatives of employers (BCCI) and workers (NTUCB) for their observations;
- II. Observations received were attached to final reports submitted to ILO Headquarters.

(Low response rate)

<u>2017 to present</u>

- I. The Ministry submits Articles 19 and 22 reports to the Labour Advisory Board (tripartite in membership);
- II. Tripartite members reports to their in-house committees/councils for review (e.g. BCCI's Labour Sub Council);

Consultation cont.

2017 to present

- III. Tripartite members submit their orgnaisations' observations; (robust discussion)
- IV. The Labour Advisory Board amends report to reflect additional information and observations received from tripartite members are attached to the report (e.g. MLC);
- V. Report with observations are submitted to the Cabinet;
- VI. Final report communicated to the ILO.

(High response rate)
