

PROJECT: Transformation to an Open Public Administration in Belize

In advancing open government in Belize through a multi-stakeholder co-creation approach, the Trust for the Americas and the Organization of the American States (OAS), are supporting during 2020 the development of Belize's first open government action plan. The Action Plan is intended to serve as the instrument to orient the actions of all actors in Belize to accomplish certain commitments in different topics and sectors.

The co-creation process entails a participatory approach to identify areas of opportunity to utilize open government in pursuing new policies, improved government services, innovative transparency efforts, etc. At the end of the co-creation process and much public consultation, agreed areas of opportunities will become what are known as open government commitments within the action plan.

Currently, open government plans of action from around the world, as pre 79 OGP participating countries and 20 subnational governments have made over 3,100 commitments to make governments more open and accountable. The following is a snapshot of action plans up to 2016 according to the OGP:





In the case of Belize and with the support of the OAS/Trust project, the activities outline in this document seek to initiate the process of developing its action plan as a sustained process aimed to be completed in December of 2020. The result of these initial dialogues scheduled for March 2020 is intended to define the priority areas that will guide Belize's open government action plan. The events will be facilitated and accompanied by experts attending from Washington DC and other parts of the world.
