EDUCATION AND TRAINING ACT, CHAPTER 036

Section 2: revision of definitions of "child" and child of compulsory school age"

Recommendations:

1. definition of "child": The definition should be revised to mean a person under the age of 18.

2. definition of "child of compulsory school age": The definition should be changed to "Compulsory education"; this should refer to compulsory education for all children, vocational or otherwise, rather than compulsory age when the child can leave school.

Section 50 (2), Recommendation:

Develop a code of Conduct to include provisions for -

- Protection from bullying;
- protection from illegal activities by persons on the school compound including other students;
- Standardize disciplinary code;
- Procedure for disciplinary action;
- Protection from extreme forms of punishment and outline acceptable forms of discipline;
- Outreach to educate teachers on acceptable and unacceptable forms of discipline; and
- Revise rules to include all the above issues.

Section 52 (b), Recommendation: Delete the sub-section (b).

Section 59: Recommendations:

1. Delete the words "who is five years old by the first day of September and who has not exceeded the age of fourteen" and substitute with the words "who has not completed compulsory education".

2. Delete the word "fourteen" occurring secondly and substitute with the word "eighteen".

Section 61(1), Recommendations:

1. Delete the words "of compulsory school age" in subsections (1) and (2).

2. Delete subparagraph (c) and substitute with the following new subparagraph "unless there is any reason by the parent that is justifiable to the truancy officer".

Section 65 (1), Recommendation: The penalty for a first offence should include some sort of social services intervention with no fine, however for a second offence a person should be subject to a fine of not exceeding \$100.

THE LABOUR ACT, CHAPTER 297

General recommendation:

The definition of "Labour Worker" causes confusion when tied to a contract of employment and should be deleted.

Section 2, Recommendations:

- 1. Insert definition of "child" to mean a person under the age of 18.
- 2. Insert a definition for "young person" to mean a person who has attained the age of sixteen years but is under the age of eighteen years.
- 3. Insert a definition for "family undertaking" to mean a small or micro enterprise which is owned and operated mainly by members of the same family.
- 4. "Disabled Person" should be revised to ensure it is in compliance with the internationally accepted definition.
- 5. Insert definition of "light work" to mean work that
 - a) may be performed by a child who is 13 years of age or older;
 - b) is not likely to be harmful to a child's physical health, mental health, safety, moral or general welfare or development;
 - c) does not prejudice the child's school attendance or participation in training and vocational programs, or the child's capacity to benefit from such instruction;
 - d) Is not performed between the hours of 6 pm and 6 am; and
 - e) does not exceed-
 - (i) If the child is 13 years of age, 1 hour on a school day or 2 hours on a nonschool day and in any case does not exceed 7 hours per week; or
 - (ii) If the child is between 14 and 16 years of age, but has not completed compulsory education, 2 hours on a school day or 6 hours on a non-school day and in any case does not exceed 28 hours per week, except during school vacation period.
- 6. Insert a definition for "hazardous work" to mean Work which is likely to harm the health, safety, morals or education of a child, including but not limited to
 - a) Work which exposes a child to physical, psychological, or sexual abuse;
 - b) Work that is performed underground, under water, at dangerous heights, or in confined spaces;

- c) Work with dangerous machinery, equipment, and tools, or which involves the manual handling or transport of heavy loads;
- d) Work in an unhealthy environment, which may expose a child to dangerous substances, agents, or processes, or to temperatures, noise levels, or vibrations damaging to their health; (Consider including a table with a weight chart)
- e) Work under particularly difficult conditions such as work for long hours or between the hours of 6 pm and 6 am, or work where the child is unreasonably confined to the premises of the employer; (define the term "Unreasonably confined").
- f) Work that exceeds two hours on a school day or six hours on a non-school day, and in any case exceeds twenty-eight hours per week except, during school vacation periods or where the child has completed compulsory education; and

Under certain circumstances, a young person i.e. a child that is 16 or 17 years of age, 17 may perform work listed on the hazardous work list if the work is identified as a hazard that can be mitigated and adequate training, supervision and safety measures are provided, as necessary.

- 7. Insert definition of "worst forms of child labour" to mean
 - a) All forms of slavery and similar practices including trafficking, bonded labor, and compulsory labor;
 - b) Using, procuring, or offering a child for prostitution, producing pornography or similar practices;
 - c) Work that is likely to harm the health, safety, morals or education of a child; or
 - d) Using, procuring, or offering a child for illicit activities including -
 - (i) the production or trafficking of drugs;
 - (ii) gang activity;
 - (iii) trafficking of firearms or ammunition; or
 - (iv) importation and handling of contraband.

Section 31, Recommendations:

- 1. Delete the word "child" in the proviso.
- 2. Include a requirement for parental consent for a child to be employed.

Section 54 (2), Recommendations:

- 1. Delete the words "non-adults" and substitute with the words "young persons".
- 2. A young person should be allowed to sign without the consent of the parents if:
 - a. They have completed compulsory education; or
 - b. Under any other circumstances as the Labour Commissioner thinks fit.

Section 71, Recommendation: Delete the words "who has attained the age of sixteen years".

Section 77, Recommendation: Increase the fine from \$500.00 to \$1,000.00.

Section 160 (1), Recommendations:

1. Paragraph (a) -- delete paragraph (a).

2. **Paragraph** (b) -- delete the words "persons who are under the age of 16 years" and substitute with the words "a child"

- 3. **Paragraph** (c) (i) delete the words "persons who are under the age of 16 years" and substitute with the words "young persons"
 - (ii) Delete the words "5 pm" and substitute with the words "6 pm".

Section 161 (1), Recommendation: Delete the words in paragraph (b) and substitute with the following "a child".

Section 161 (2), Recommendation: increase the penalties from \$150. to \$5,000.

Section 162 (1), Recommendation: Labour Department to determine whether or not the discriminatory reference to women will be removed from the Act.

Section 162. (2), Recommendation: Delete subsection (2).

Section 162 (3), Recommendation: - Delete the words "male persons between the ages of 16 and 18 years" and substitute with the words "young person"

Section 162 (4), Recommendation: Delete the words "persons under the age of eighteen years" and "male persons between the ages of 16 and 18 years" and substitute with the words "young person"

Section 162 (5), Recommendation: Delete subsection (5)

Section 162 (6), Recommendation: Delete subsection (6)

Section 163 (1), Recommendation: Delete Section 163 as section 16 applies to all workers.

Section 164 (1), Recommendations:

1. Insert the words "under the age of 13 years" after the word child.

2. Delete the word "children" and substitute with the word "child", insert the word "a" immediately before the word "technical" and delete the word "schools" and substitute with the word "school".

Section 166, Recommendation: Delete Section 166 as it may no longer be applicable.

Section 167 (1), Recommendation: Delete Section 167 as it may no longer be applicable.

Section 168 (1), Recommendation: Delete Section 168 as Section 16 applies to all workers.

Section 169, Recommendations:

1. Paragraph (a) - delete the word "twelve" and substitute with the word "thirteen";

2. **Paragraph** (c) - delete the words in paragraph (c) and substitute with the words "before 6 am or after 6 pm on any day";

3. **Paragraph** (d) - delete the words in paragraph (d) and substitute with the words "2 hours on a school day and four hours on a non-school day";

4. Paragraph (e) - delete paragraph (e);

5. Paragraph (f) - delete paragraph (f);

6. Paragraph (g) - delete paragraph (g);

7. Include a provision which states that the minimum age for a child to be in full-time employment is where the child has attained 16 years of age and has completed compulsory education.

8. Include a provision stating that a requirement for full-time employment of a child prior to completion of compulsory education must be by way of application to the Labour Commissioner;

9. To approve an application, the Labour Commissioner must acquire written approval of the Ministry of Education and the Ministry of Human Development.

Section 170 (1), Recommendation: Subsection (1)(a) - delete the word "twelve" and substitute with the word "thirteen"

Section 171, Recommendation: define entertainment or use a different word (cultural or educational performance), and insert a time frame (insert examples and a list of like kind.

Section 172 (1), Recommendations:

1. Subsection (1) - the fines should be charged based on the size of the business that employs the child as follows:

- (a) If offender is a small business, increase of fine to \$1,000 and 1-year imprisonment; and
- (b) If offender is a corporation, increase of fine to \$5,000 and 1-year imprisonment.
- 2. Subsection (2) the fines should be charged as follows:
 - (a) Parent's first offence Probation or community service; and
 - (b) Parent's second offence fine of \$25 and \$500.

Section 174, Recommendation: The section should be deleted as the Criminal Code deals with falsification of documents so.

Section 175, Recommendations:

1. Define manual labour.

2. Include parameters for manual labour that children in an institution/ detention center can do, in accordance with the light and hazardous list.

Section 176A(1), Recommendation: Insert a subsection in accordance with section 13 of Families and Children Act.

CRIMINAL CODE ACT, CHAPTER 101

General recommendation: Include a definition for child, to mean a person under the age of 18.

WORKMEN'S COMPENSATION ACT, CHAPTER 303

General recommendation: Remove the reference to illegitimate child.

Section 2 (1), Recommendation: separate the definition of "adult" and "minor" and replace the definition of a minor with the definition of a child

DISTRICT COURTS (PROCEDURE) ACT CHAPTER 97

General recommendation: Include the definition of a "Child"

Section 8, Recommendations:

1. Remove the provision in the section for cost to be awarded against a child who sues an employer for wages.

2. (Action by infant for wages. 8 of 1970. 21 of 1985. 10 of 2010) Marginal note refers to "infant" change to child

FAMILIES AND CHILDREN ACT, CHAPTER 173

Section 2, Recommendation: replace the definition of "child" with LRC's definition of child

Section 7, Recommendation: Remove the conditions for employment of a child and reference the definition of hazardous work in accordance to the Labour Act

Section 13, Recommendation: Insert a subsection (2) to say that cost cannot be recoverable against a child who sues an employer for wages.

Section 51, Recommendation: Delete the words "unless the contrary is shown" and substitute with the words "unless the child has completed compulsory education and is in fulltime employment"

MOTOR VEHICLE ROAD TRAFFIC ACT, CHAPTER 230

General recommendation: Include the LRC's definition of "Child".

Section 29 (4), * Note: There is no requirement for a license to drive a tractor, there needs to be a determination if this job will be included in hazardous work list.

Section 35, Recommendation: Delete the words "under the age of eighteen years" and substitute with "child"

Section 87 (1), * Note: This section is not in compliance with the age of criminal responsibility for a child.

SHOPS ACT, CHAPTER 287

Section 3 (1), Recommendation:

- 1. Delete the words "fourteen years" and substitute with the words "thirteen years".
- 2. Insert the words "except to do light work", after the word "Shop".
- 3. Insert a new sub-section (3) that provides the definition of Light work.

Section 5 (1), Recommendation: delete the words "persons under the age of eighteen years" and substitute with the word "child"

Section 7 (1), Recommendation: Add a new sub-section (7) as follows – Notwithstanding this section a child may be employed part time in accordance with section 3(as amended above)

EQUAL PAY ACT, CHAPTER 302.01

Section 8 (1), Recommendation: Subsection (1) - instruct after the word "women" the words "or a child who has attained compulsory education"

Section 9 (2), Recommendation: Delete the words "who employs both men and women".

FACTORIES ACT, CHAPTER 296

Section 2, Recommendations:

1. Replace definition of "young person with the LRC's definition of young person.

2. Delete the reference to "young persons" in the Act and Regulations.

3. Include a provision for children to work in accordance to the Light Work List and Hazardous Work Lists.

Section 50, Recommendation: delete the word "female", in the section.

Section 58, Recommendation: delete every reference to "young person" in the section.

JUVENILE OFFENDERS ACT, CHAPTER 119

Section 2, Recommendations:

1. Delete the definition of "child" and substitute with the LRC's definition of child.

2. Delete the definition of "young person" and substitute with the LRC's definition of a young person.

Section 14 (1), Recommendations:

1. Delete the words "under the age of eighteen years" in the entire Legislation and substitute with the word "child"

2. Delete all references to illegitimate child.

PENAL SYSTEM REFORM (ALTERNATIVE SENTENCES) ACT, CHAPTER 102.01

Section 2, Recommendations:

1. Include the LRC's definition of light work and hazardous work lists.

2. Delete the definition of "juvenile" and substitute with the definition of "child".

GOVERNMENT WORKERS REGULATIONS

Section 2, Recommendation: The LRC definition of "child" and "young person" should be inserted.

Section 21 (1), Recommendations:

- 1. Subsection (2)
 - a) In the heading, delete the words "part IV" and substitute with the words "part XIII".

b) Delete the words "over 14 but under 18 years of age"

- 2. Subsection (2)(a) Delete the words,
 - a) "Women and",
 - b) delete the word "may" and substitute with the word "shall"; and
 - c) "between the hours of 10 p.m. and 6 a.m.".

3. Subsection (2)(a)(ii) –The Ministry responsible for the Government Workers Regulation will need to amend the legislation in accordance with Labour Department's recommendation in the Labour Act Section 162(1).

4. Subsection (2)(b) – Adopt the recommendation for employment of children on vessels under the Labour Act.
